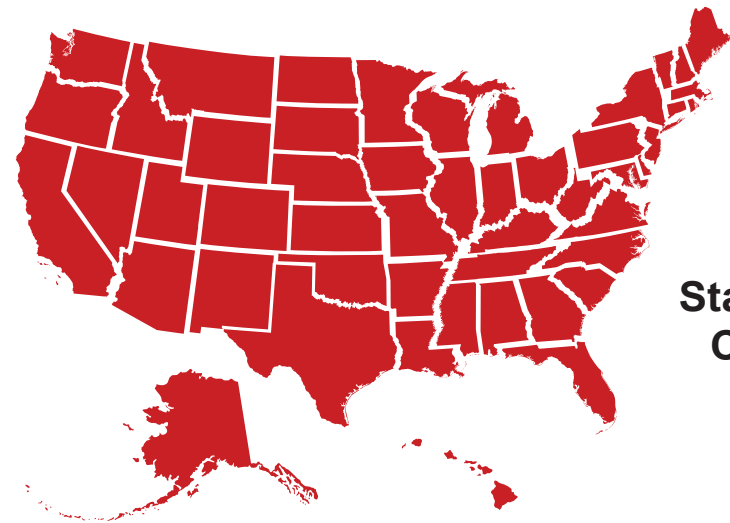

## COMMERCIAL MOTOR VEHICLE SAFETY ACT OF 1986

### **Section 1:**

#### **One Driver's License:**

Operator shall not have more than one driver's license.

### **Section 2:**

#### **Information System:**

An information system will be established to serve as a clearing house so a state or employer may check the status of a driver's CDL.

### **Section 10:**

#### **Serious Traffic Violations Involving Commercial Vehicle\*\*:**

- (a) Two serious violations within a 3-year period = 60-day suspension
- (b) Three serious violations within a 3-year period = 120-day suspension
