This member was in a serious accident where three people died. He was charged with 3 counts of misdemeanor death. He was facing 18 years in jail, a \$4,500 fine and three-year suspension.

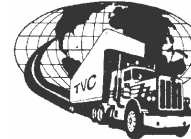
