This member was in a serious accident where three people died. He was charged with 3 counts of misdemeanor death. He was facing 18 years in jail, a \$4,500 fine and three-year suspension.

We got him no jail time, no probation, and only a \$500 fine. He couldn't drive in North Carolina for one year.

Thanks to TVC and the Provider Attorney and pursuant to a plea arrangement with the State, Mr. Smith pled guilty to all counts and received the following:

**NO JAIL TIME**

**NO SUPERVISED PROBATION**

**\$500 FINE**

**ONE YEAR REVOCATION OF DRIVING PRIVILEGES IN STATE WHERE ACCIDENT OCCURRED. HOWEVER, HE IS ALLOWED TO DRIVE IN HIS HOME STATE AND ALL OTHER REMAINING STATES IN THE U.S.**

All sales made of **DriverShield** Gas Money will fall within a **DriverShield** Matrix, which is separate from the TVC Matrix. The **DriverShield Plan** pays a \$50.00 advance\* fast start commission when collecting first months dues with an ongoing payment method. Since this is a separate company, no TVC bonuses will be paid on **DriverShield** Gas Money sales. This includes, but is not limited to, Cash Winner Bonus, Insurance Bonus and Executive Director Bonus. However, **DriverShield** Gas Money sales will count toward your weekly and monthly sales qualification counts for these bonuses. A **DriverShield** Gas Money sale will qualify as 1 PGV. Only sales with ongoing payment methods will be accepted.

If you refer or sell two (2) people a week, you would earn \$100 a week Gas Money. Also, everyone you bring in can do the same, which would increase your monthly Matrix Gas Money much faster than the hypothetical example above. Your Matrix money is paid once a month, over and above the weekly fast start.

# **CLOSE THE SALE...**

**IMMEDIATELY** pick up the packet. (Build value...)

We are going to give you this card, stickers for your truck and your logbook. Here are your power of attorneys. If you have a ticket or accident, call this 800# and they will help you. Here is a summary of your benefits that we talked about.

What is your name?.... What is your address?.... What is your phone number?... What is your social?

Complete the membership card while chatting (about the weather, where he's headed, the price of gas, anything but the price). Do not mention check, bank, credit card, etc. Once you complete the top part of the application, say, "We bill you through your bank, do you have that card in your wallet?"

Look the driver in the eye, hold out your hand, and BE QUIET!

Once you have payment, say, "By the way, we like to do a first and last month draft so that your membership is never cancelled by mistake, is that okay?"

Have the member sign the app. Give him his packet.

Shake his hand and tell him Thank You and to Drive Carefully



# PRE-EXISTING TICKETS

If a driver has a ticket, he is only thinking about the ticket. Tell him we can help him... then sell the membership as above. When you get to the Pre-Existing page, tell him he will send the handling fee to TVC, all you need today is to get the membership started so we can get working on his ticket.

Take the stand that if he had had this membership, he would not be in pre-existing status, but the next time he gets a ticket, he will just need to call it in.

Remember, you are not an attorney. Tell him he needs to speak with one of our legal supervisors so that they can help him with his ticket. And remind him that it requires a membership for that to happen.

Free consultations for the 25% discount and pre-existing citations are all handled the same way. A membership is required to speak with a legal supervisor.

If they want a guarantee, tell them we are not in business because we aren't doing our job. If anyone can win, we can. They won't be disappointed.
