### INFORMATION TO HELP YOUR MEMBERS

#### CALL FIRST, MAIL SECOND

Always instruct your members to call in their citations to the office before mailing them. Each state can vary regarding the information and forms they want from the driver. By asking the driver to make the phone call first, we can save the driver time and frustration by ensuring that he is informed early on of what information the attoreny will need from him.

### COURT DATE EXTENSIONS & PRE-FEES ON PRE-EXISTING TICKETS

Pre-Existing tickets are tickets a member gets before he enrolls or within the first 10 days of enrollment. The Pre-Fee is \$295 as long as we have notice of the ticket at least 10 BUSINESS days prior to the court date. If we have less time, the Pre-Fee is \$395, provided we have time to assign an attorney.

If your member needs a court date extension to gain additional time to pay the pre-fee, or so that he can make payment arrangements, the member needs to call the court to get the extension himself.

### Information to Help Your Members

#### **DAC REPORTS**

The DAC Report (also known as USIS Report) is an independent reporting agency which subscribes trucking companies throughout the United States and Canada. Company subscribers are allowed to report and look up reports on drivers regarding driving records (points, accidents or serious Federal violations). employment history (tardiness, not showing up, etc.), and other negative impacts on employing a driver (such as failed drug tests).

Because they are an independent agency, only reporting the information given, a driver cannot "sue" DAC for incorrect information. If you enroll a member who has incorrect information on his DAC Report, we can help him in two ways.

The first is to give the driver DAC's toll-free 800 number (800-381-0645). The DRIVER must call to let them know that there is incorrect information on their DAC Report. DAC has a procedure to remove untrue information and will instruct the driver on that procedure.

If the Driver cannot get the incorrect information removed, we can help him through our 25% Discount Attorney service. The Driver will get a free consulation with one of our Attorneys to discuss who reported the untrue information and what
